

3. Tender fees: -

The tender fees has been fixed as ₹200 only for SSI unit of J&K State in the shape of scanned copy of treasury challan deposited into State Govt. treasury under object head 0055-Police and the same is non-refundable. Treasury Challan should compulsorily mention (i) Name of the firm (ii) Tender No. (iii) Date of opening of tender.

4. Earnest Money Deposit (EMD): -




